## Anti Poverty Policy in Belgium

- *Poverty is the result of network of social exclusions which often even reinforce each other. People do not (or no longer) manage to participate in society. There is a rupture in one or more areas of life. The generally accepted standard of living is no longer reached. People experiencing poverty are often unable to bridge this gap on their own.*

- Evolution Participation National Action Plans
- NAPincl 2001-2003
  - **Made by ministerial Cabinets**
  - **Based on existing policy declarations of federal entities**
- NAPincl 2008-2010
  - **Coordination and final redaction by POD-MI**
  - **Strategic Priorities and objectives defined by stakeholders**
  - **Federal entities had to fit their measures in this framework.**
  - **Targets**
  - **Approuvment by IMC-MI**
